3. **L06-325 - Bayou L'Ourse Gravity Drainage District No. 1, Assumption Parish** - \$50 parcel fee, 15 years, 2007-2021, for the purpose of paying the cost of constructing and maintaining levees, levee drainage, flood protection, hurricane flood protection, and all purposes incidental thereto, including paying compensation for the exercise of permanent or temporary servitudes, and to pay, in whole or in part, the payment of principal and interest on bonds of said district.
4. **L06-328 - Landry Subdivision Gravity Drainage District No. 7, Assumption Parish** - \$50 parcel fee, 15 years, 2007-2021, for the purpose of paying the cost of constructing and maintaining levees, levee drainage, flood protection, hurricane flood protection, and all purposes incidental thereto, including paying compensation for the exercise of permanent or temporary servitudes, and to pay, in whole or in part, the payment of principal and interest on bonds of said district.
