35. **S13-013 - Louisiana Community Development Authority (BioNitrogen Louisiana Holdings, LLC Project) -** Not exceeding \$1,250,000,000 Solid Waste Disposal Facility Revenue Bonds, taxable or tax-exempt, or both, in one or more series, not exceeding 15% fixed or variable rate, not exceeding 25 years, development and construction of multiple urea manufacturing facilities to be located at or near the Pointe Coupee Port operations along the Mississippi River, which facilities will transform residual agriculture solid waste and other biomass materials into bulk urea product.
