3. **L07-294 - Acadia Parish, Town of Iota** - 9 mills tax, 10 years, 2008-2017, construction, maintenance, repair, overlay and replacement of public streets, roads, avenues, alleyways and bridges (including drainage and equipment necessary therefor).
4. **L07-329 - Allen Parish, Ambulance Service District No. 1** - 10.02 mills tax, 10 years, 2009-2018, acquiring, maintaining and operating equipment and facilities necessary to provide ambulance service and care for the residents of the District.
5. **L07-336 - Allen Parish, City of Oakdale** - 5.78 mills tax, 10 years, 2007-2016, acquiring, constructing, improving, maintaining and operating fire protection facilities in the city, including the purchase of fire trucks and equipment therefore.
