3. **L09-437 - Allen Parish, Village of Reeves** - 1% sales tax, years, beginning January 1, 2010 and run in perpetuity, dedicated and used for such lawful purposes as determined by the Governing Authority of the Village including without limitation, support of the General Fund of the village, subject to funding into bonds.
4. **L09-353 - Calcasieu Parish, Ward Four Fire Protection District No. Two** - 6.5 mills tax, 10 years, 2010-2019, maintaining, operating and developing fire protection facilities, for purchasing fire trucks and other fire fighting equipment, and for paying the cost of acquiring, improving and constructing fire protection facilities.
5. **L09-354 - Calcasieu Parish, Recreation District No. 1, Ward 4** - 10.55 mills tax, 10 years, 2011-2020, acquiring, constructing improving, maintaining, and operating facilities.
