3. **L07-399 - Allen Parish, Recreation District No. II** - 4.87 mills tax, 10 years 2008 - 2017, acquiring, constructing, maintaining and operating recreational facilities.
4. **L07-438 - Allen Parish School Board, School District No. 4** - Not exceeding \$2,035,000 General Obligation Bonds, not exceeding 7%, not exceeding 20 years, for improving building sites and playgrounds, including construction of necessary sidewalks and streets adjacent thereto; purchasing, erecting and/or improving school buildings and other school related facilities within and for the District and acquiring the necessary equipment and furnishings therefor.
5. **L07-439 - Allen Parish School Board, School District No. 25** - Not exceeding \$6,500,000 General Obligation Bonds, not exceeding 7%, not exceeding 20 years, for improving land for building sites and playgrounds, including construction of necessary sidewalks and streets adjacent thereto; purchasing, erecting and/or improving school buildings and other school related facilities within and for the District and acquiring the necessary equipment and furnishings therefor.

37. **L07-407 - Washington Parish Council, Washington Parish Voluntary Council on Aging** - 2.8 mills tax, annually beginning 2008, providing funds to the Washington Parish Voluntary Council on the Aging in order to provide transportation services, delivery of meals, provision of on-site meals, Medicare counseling, telephone monitoring, a wellness program for clients of the Washington Parish Voluntary Council on the Aging, and other general operations of the Washington Parish Voluntary Council on the Aging.
38. **L07-424 - Washington Parish, City of Bogalusa** - (1) 1/4% sales tax, (i) improving and/or maintaining the City's industrial park, (ii) constructing additions and improvements to existing buildings in the industrial park and (iii) constructing, acquiring and improving additional buildings therein; (2) 2.71 mills tax, 10 years, 2008-2017, maintaining fire department stations and equipment, and for paying the general operations thereof and salaries of the personnel of the fire department; (3) 2.71 mills, 10 years, 2008-2017, maintaining sewerage and water works and other works of permanent improvement under the jurisdiction of the Department of Streets and Parks; (4) 3.62 mills tax, 10 years, 2008-2017, maintenance and operation of municipal services departments, including the acquisition of necessary equipment therefore and paying salaries of the personnel of said departments.

45. **L07-429 - Iberville Parish, City of St. Gabriel** - Not exceeding \$600,000 Budgetary Loan, not exceeding 6%, maturing no later than March 1, 2008, current expenses.
46. **L07-370 - Ouachita Parish, G. B. Cooley Hospital Service District** - Not to exceed \$750,000 Certificates of Indebtedness, interest at a rate not to exceed 6%, mature no more than 10 years from the date of issuance, acquiring, constructing, renovating and equipping group homes for persons with mental retardation or related conditions.
47. **L07-430 - St. John the Baptist Parish Council** - Not to exceed \$600,000 Certificates of Indebtedness, interest at a rate not to exceed 6%, maturing no more than 15 years from the date of issuance, acquiring fire fighting equipment, buildings and machinery, as may be necessary in the area of the Garyville Fire Department.
48. **L07-408 - Tensas Parish, Parishwide Fire Protection District No. 1** - Not exceeding \$160,000 Anticipation of Avails Certificates of Indebtedness, not exceeding 5-1/2 %, not exceeding 5 years, acquiring, constructing, and improving fire protection facilities and equipment.
49. **L07-431 - Vermilion Parish, Hospital Service District No. 2** - Not exceeding \$500,000 Certificates of Indebtedness, not exceeding 4.19%, maturing serially October 1 of the years 2008 through 2012, acquiring and installing hospital equipment, including endoscopic equipment in the GI laboratory at Abbeville General Hospital.

- 50. **L07-352 - West Feliciana Parish Police Jury, Consolidated Waterworks District No. 13** - Not exceeding \$280,000 Excess Revenue Loan, not exceeding 5%, maturing no more than 10 years, acquisition of improvements and extensions to the waterworks system of the Issuer.
