**TAB 3 - LOCAL GOVERNMENTAL UNITS - ELECTIONS (DECEMBER 8, 2012)**

3. **L12-424 - Ascension Parish, Fire Protection District No. 1 - (1) 15 mills tax and (2) (a) \$100 annual parcel fee for commercial parcels and (b) \$32 annual parcel fee for residential parcels, all to be levied for 10 years, 2013-2022, (i) acquiring, constructing, maintaining and operating fire protection facilities and equipment and (ii) funding into bonds.**
4. **L12-423 - Ascension Parish, Road Lighting District No. 1, 2, 3, 4, 5 and 6 - (1) Road Lighting District No. 1 - 5 mills tax, 10 years, 2013-2022, providing and maintaining electric lights on streets, roads, highways, alleys and public places; (2) Road Lighting District No. 2 - 5 mills tax, 10 years, 2013-2022, providing and maintaining electric lights on streets, roads, highways, alleys and public places; (3) Road Lighting District No. 3 - 5 mills tax, 10 years, 2013-2022, providing and maintaining electric lights on streets, roads, highways, alleys and public places; (4) Road Lighting District No. 4 - 5 mills tax, 10 years, 2013-2022, providing and maintaining electric lights on streets, roads, highways, alleys and public places; (5) Road Lighting District No. 5 - 5 mills tax, 10 years, 2013-2022, providing and maintaining electric lights on streets, roads, highways, alleys and public places; (6) Road Lighting District No. 6 - 5 mills tax, 10 years, 2013-2022, providing and maintaining electric lights on streets, roads, highways, alleys and public places.**
5. **L12-422 - Tangipahoa Parish Council, Garbage District No. 1 - 10 mills tax, 10 years, 2013-2022, acquiring, constructing, improving, maintaining or operating garbage collection and disposal systems and services.**
6. **L12-405 - Terrebonne Parish, Terrebonne Levee and Conservation District - 1/2% sales tax, 28 years, beginning April 1, 2013, (1) providing hurricane risk reduction projects including Morganza to the Gulf or other flood protection improvements approved by the Louisiana Coastal Protection and Restoration Authority; and (2) funding into bonds.**

7. **L12-449 - Ascension Parish, Library Board of Control - To authorize the Ascension Parish Library Board of Control to enter into a Local Services Agreement with the Parish Council in which the Library Board will provide funds to repay the parish obligation for Refunding Bonds not exceeding \$9,350,000, not exceeding 5%, to mature no later than April 1, 2035, to be issued on behalf of the Library Board under L12-437.**
8. **L12-429 - Caddo Parish Commission - Not exceeding \$6,000,000 Limited Tax Certificates of Indebtedness, not exceeding 5%, not exceeding 10 years, acquiring, equipping, constructing and improving (including acquisition of library books, materials and equipment) the public library system, including branches.**
9. **L12-434 - East Baton Rouge Parish, Recreation and Park Commission - Not exceeding \$8,000,000 Revenue Anticipation Notes, Series 2012, not exceeding 2%, mature no later than March 1, 2013, current operations.**

10. **L12-439 - East Baton Rouge Parish, St. George Fire Protection District No. 2** - Not exceeding \$2,730,000 Certificate of Indebtedness, Series 2012, not exceeding 3%, maturing no later than November 1, 2019, refunding Certificate of Indebtedness, Series 2005 and 2009.
11. **L12-451 - Iberville Parish, City of Plaquemine** - Not exceeding \$1,000,000 Taxable Revenue Bonds, Series 2012, in one or more series, not exceeding 5%, not exceeding 4 years, paying capital and operating expenditures incurred in connection with Hurricane Isaac.
12. **L12-433 - Lafayette Parish Assessment District** - Not exceeding \$560,000 Revenue Anticipation Notes, Series 2012, not exceeding 6%, mature no later than March 1, 2013, current expenses.
13. **L12-448 - Livingston Parish, Sewerage District No. 1** - To authorize Sewerage District No. 1 to enter into a Local Services Agreement with Sewerage District No. 2 in which District No. 1 will provide funds in an amount not exceeding \$4,285,000, not exceeding 4.375%, not exceeding 30 years, to repay a portion District No. 2's obligation for Revenue Bonds to be issued on behalf of District No. 1 for improvements and extensions to the Sewer System (L12-419).
14. **L12-430 - St. John the Baptist Parish Law Enforcement District** - Not exceeding \$3,000,000 Revenue Anticipation Notes, not exceeding 6%, mature no later than June 30, 2013, current expenses.
15. **L12-396 - St. Tammany Parish, Fire Protection District No. 4** - Not exceeding \$600,000 Limited Tax Certificates, Series 2012, not exceeding 5%, not exceeding 10 years, acquiring vehicles and equipment.
16. **L12-426 - West Carroll Parish Police Jury** - Not exceeding \$1,534,000 Letter of Credit, not exceeding 6%, not exceeding 1 year, (1) satisfying DEQ's financial assurance requirements for the payment of closure costs for the Landfill and (2) incur debt to the extent that funds are drawn from said Letter of Credit.

21. **L12-402 - Jefferson Parish, City of Kenner, Kenner Consolidated Sewerage District (DEQ Project)** - Not exceeding \$21,000,000 Sewer Revenue Bonds, not exceeding 0.95%, not exceeding 22 years, acquiring and constructing additions, extensions and improvements to the wastewater collection, treatment and disposal system.
22. **L12-420 - Jefferson Parish, Town of Grand Isle (DEQ Project)** - Not exceeding \$853,000 Sewer Revenue Bonds, Series 2012, non-interest bearing, not exceeding 20 years, acquiring, constructing and installing improvements, extensions and additions to the wastewater collection, treatment and disposal system.
23. **L12-436 - Jefferson Parish School Board** - Not exceeding \$25,000,000 Sales Tax Refunding School Bonds, in one or more series, not exceeding 5%, mature no later than February 1, 2025, refunding all or a portion of Sales Tax School Bonds, Series 2005.
24. **L12-445 - Lafayette Parish, City of Lafayette** - Not exceeding \$200,000,000 Utilities Revenue Refunding Bonds, not exceeding 6%, not exceeding 17 years, refunding all or a portion of Utilities Revenue Bonds, Series 2004.
25. **L12-438 - Lafayette Parish, Lafayette Public Power Authority** - Not exceeding \$88,000,000 Electric Revenue Bonds, not exceeding 6%, not exceeding 25 years, (1) improvements, renewals, repairs and replacements for the Rodemacher Unit No. 2 fossil fuel steam electric generating plant; (2) purchasing and acquiring equipment; (3) purchasing and acquiring facilities for the transportation, handling and storage of fuel for the operation of Rodemacher Unit No. 2; and (4) funding a reserve fund.
26. **L12-432 - Lafourche Parish Law Enforcement District** - Not exceeding \$3,000,000 Limited Tax Revenue Bonds, not exceeding 6%, not exceeding 15 years, making capital improvements, including construction and acquisition of improvements to the building and grounds located at 300 Lynne Ave. in Thibodaux.
27. **L12-421 - LaSalle Parish, Hospital Service District No. 1** - Not exceeding \$1,285,000 Hospital Revenue Bonds, Series 2012, not exceeding 4.5%, not exceeding 15 years, improve and renovate patient wings at Hardtner Medical Center, including equipment, accessories and furnishings.
28. **L12-419 - Livingston Parish, Sewerage District No. 2** - Not exceeding \$16,900,000 Revenue Bonds, in one or more series, not exceeding 4.375%, not exceeding 30 years, (1) acquire, construct, extend and improve the sewerage system within Sewerage District No. 1 and Sewerage District No. 2 and (2) fund a debt service reserve fund.
29. **L12-443 - Morehouse Parish, City of Bastrop** - Not exceeding \$4,600,000 Sewer Revenue Refunding Bonds, Series 2012, not exceeding 3.75%, mature no later than November 1, 2028, (1) refunding Sewer Revenue Bonds, Series 2002, 2003 and DEQ Sewer Revenue Bonds, Series 1994 and (2) fund a debt service reserve fund, if required.
30. **L11-448A - St. Landry Parish, Waterworks District No. 5** - Not exceeding \$374,000 Water Revenue Bonds, Series 2012, not exceeding 3.375%, not exceeding 40 years, acquiring and constructing a waterworks system, including appurtenant equipment, fixtures and accessories.

31. **L12-428 - St. Tammany Parish, Northshore Harbor Center District** - Not exceeding \$2,200,000 General Obligation Refunding Bonds, not exceeding 5%, mature on or before March 1, 2024, refunding all or a portion of General Obligation Bonds, Series 2004.
32. **L12-441 - Washington Parish, City of Bogalusa** - Not exceeding \$2,260,000 General Obligation Refunding Bonds, Series 2012, not exceeding 2.5%, mature no later than April 1, 2018, refunding General Obligation Bonds, Series 1998.
33. **L12-435 - Winn Parish, City of Winnfield** - Not exceeding \$1,500,000 Sewer Revenue Bonds, not exceeding 0.95%, not exceeding 22 years, constructing and acquiring improvements and replacements to the sewerage system of the City.
