**TAB 3 - LOCAL GOVERNMENTAL UNITS - ELECTIONS (NOVEMBER 7, 2006)**

3. **L06-403 - Fire Protection District No. 2, Allen Parish** - 9.00 mills tax, 15 years, 2007-2021, acquiring, constructing, improving, maintaining and/or operating fire protection facilities and equipment and paying the cost of obtaining water for fire protection services.
4. **L06-432 - Fire Protection District No. 6, Allen Parish** - 13.66 mills tax, 10 years, 2008-2017, acquiring, constructing, improving, maintaining and/or operating fire protection facilities and equipment and paying the cost of obtaining water for fire protection purposes.
5. **L06-476 - Hospital Service District No. 3, Allen Parish** - 3.00 mills tax, 10 years, 2007-2016, acquiring, maintaining, operating, improving and constructing hospital houses, buildings and facilities, including equipment, and any other maintenance and operation needs in the district.
6. **L06-419 - Ascension Consolidated Utility District #1** - 10 mills tax, 25 years, 2007-2031, acquiring, constructing, improving, maintaining and operating the waterworks system within the district.
7. **L06-420 - Assumption Parish Police Jury, Consolidated Fire Protection District** - 5.00 mills tax, 10 years, 2007-2016, acquiring, constructing, improving, maintaining and/or operating fire protection and emergency medical service facilities, purchasing fire trucks and other fire fighting or emergency medical service equipment and payment of all related personnel costs, and paying the cost of obtaining water for fire protection purposes, including charges for fire hydrant rentals and service, provided neither of the millages currently authorized in Fire Protection District No. 1 and Fire Protection District No. 2 of said Parish are levied.
8. **L06-455 - Assumption Parish School Board, School District No. 1** - 20.81 mills tax, 10 years, 2008-2017, for the purpose of giving additional aid and support to the public schools of School District No. 1.
9. **L06-441 - Avoyelles Parish Police Jury** - \$35 service charge, 10 years, 2007-2016, for the purpose of abatement, control and eradication of mosquitoes and other arthropods of public health importance, including the acquisition, maintenance, operation and support of equipment, facilities, supplies and services.
10. **L06-467 - Beauregard Parish Police Jury, Sales Tax District No. 1** - 1% sales tax, 10 years from October 1, 2009, for constructing, improving, operating and maintaining roads and bridges within the District and acquiring the necessary equipment therefore with the monies to be allocated in the following percentages: 35% to parishwide work crews; 35% for equipment and equipment repairs; 30% to acquire materials and supplies to be divided equally by the eight wards, with the proceeds being subject to funding into bonds.

11. **L06-456 - Bienville Parish Recreation District No. 1** - 3.28 mills tax, 10 years, 2008-2017, for acquiring lands, buildings, equipment and other facilities and for the construction and maintenance thereof, and to promote recreation and any related activities within the District.
12. **L06-457 - Bienville Parish Fire Protection District No. 6** - 7.19 mills tax, 10 years, 2008-2017, for the purpose of acquiring, constructing, improving, maintaining, operating and/or purchasing fire protection equipment and facilities for the District, including payment of salaries in connection therewith.
13. **L06-458 - Wards 4 & 5 Fire Protection District, Bienville Parish** - 3.39 mills tax, 10 years, 2008-2017, acquiring, construction, improving, maintaining and operating fire protection facilities and equipment in and for Wards Four and Five Fire Protection District, including paying the cost of obtaining water for fire protection purposes.
14. **L06-423 - Caddo Parish Commission** - .10% sales tax, for mandated costs of the Parish for the criminal justice system, including, but not limited to acquiring, constructing, improving, equipping, operating, and maintaining Caddo Parish Juvenile Court and Juvenile Detention facilities for the Parish, subject to funding into bonds.
15. **L06-425 - City of Lake Charles, Calcasieu Parish** - ¼ % sales tax, 20 years, 2.5 mills tax, 20 years, not exceeding \$90,000,000 of debt in the form of bonds, notes or loans, not exceeding 7.5%, not exceeding 20 years, to be issued in various series with the proceeds used to acquire, construct, or improve streets and roads, parks and recreational facilities, water and waste water systems, downtown and/or lakefront development infrastructure and economic development facilities within the City.
16. **L06-434 - Waterworks District No. 14 of Ward 5, Calcasieu Parish** - (1) not exceeding 8%, not exceeding 20 years, \$1,288,000 General Obligation Bonds, for the purpose of acquiring, improving, extending and maintaining a waterworks system including equipment and installations within and for the district; (2) 15 mills tax, 10 years, 2007-2016, for maintaining and operating the district's waterworks system, equipment and facilities.
17. **L06-460 - Monterey Fire Protection District No. 1, Concordia Parish** - 10 mills tax, 10 years, 2007-2016, for acquiring, constructing, improving, maintaining and/or operating Monterey Fire Protection District No. 1's fire protection facilities and equipment, including paying the cost of obtaining water for fire protection purposes.
18. **L06-410 - Metropolitan Council of the Parish of East Baton Rouge and City of Baton Rouge** - 1 mill tax, 10 years, 2007-2016, for the purpose of purchasing, maintaining and operating machinery, facilities and equipment necessary in the eradication, abatement or control of mosquitoes and rodents, and maintaining adequate administrative and support staff in connection therewith.
19. **L06-435 - St. George Fire Protection District No. 2, East Baton Rouge Parish** - 1.50 mills tax, 5 years, 2007-2011, for the purpose of providing funds for capital improvements and debt service for the District.
20. **L06-462 - Evangeline Parish Police Jury, Police Jury Ward No. 1** - (1) 1.12 mills tax, 10 years, 2007-2016, for the purpose of maintaining and upkeeping public cemeteries; (2) **Police Jury Ward No. 5** - 1.00 mill tax, 10 years, 2007-2016, for the purpose of maintaining and upkeeping public cemeteries.

21. **L06-464 - (1) Evangeline Parish Police Jury, Road District No. 4** - 15 mills tax, 10 years, 2007-2016, for constructing and improving parish roads and highways within the district, or for the maintenance thereof; **(2) Road District No. 5** - 10 mills tax, 10 years, 2007-2016, for constructing and improving parish roads and highways within the district, or for the maintenance thereof; **(3) Voting District No. 6** - 1.12 mills tax, 10 years, 2007-2016, for maintaining and upkeeping public cemeteries located in the district.
22. **L06-468 - Ward Five Fire Protection District, Evangeline Parish** - 11.51 mills tax, 10 years, 2007-2016, for the purpose of acquiring, constructing, improving, maintaining and operating the District's fire protection facilities, including paying the cost of obtaining water for fire protection purposes.
23. **L06-421 - Jackson Parish School Board, Consolidated School District No. 1** - 5.37 mills tax, 10 years, 2007-2016, for the purpose of giving additional support for the maintenance and operation of the public school system in the District, including the payment of any indebtedness incurred therefore.
24. **L06-461 - Jefferson Davis Parish Police Jury, Road Sales Tax District No. 1** - 2% sales tax, 20 years, 2007-2026, constructing, improving, maintaining and resurfacing parish roads within the District excluding employees' salaries, wages and benefits, and the payment of any bonded or funded indebtedness of the District incurred for such purposes.
25. **L06-408 - Lafayette City-Parish Council** - **(1)** Not exceeding \$70,000,000 General Obligation Bonds, not exceeding 9%, not exceeding 25 years, acquiring and constructing a new courthouse, improving and renovating the existing courthouse and related facilities and acquiring the necessary furnishing therefore, title to which shall be in the public; **(2)** 2 mills tax, 10 years, 2007-2016, for the purpose of maintaining, operating and improving the courthouse complex.
26. **L06-424 - Lafayette City-Parish Council** - 1% sales tax, perpetual tax (a) purchasing, constructing, acquiring, extending, improving, equipping and furnishing streets, bridges, traffic and drainage works or capital improvements for the City and (b) paying the operation and maintenance expenses; provided, however, not less than 80% must be appropriated and expended for the purpose of purchasing, constructing, acquiring, extending, improving, equipping and furnishing streets, bridges, traffic and drainage public works or capital improvements for the City, subject to funding into bonds.
27. **L06-469 - Lafayette City-Parish Council, Sales Tax District No. 1** - 1% sales tax, purchasing, constructing, acquiring, extending, maintaining and improving public works or capital improvements for said District and acquiring the necessary equipment and furnishings and paying debt service on any obligations issued to finance such improvements.
28. **L06-478 - Lafayette City-Parish Council, City of Broussard Sales Tax District** - 1% sales tax, purchasing, constructing, acquiring, extending, maintaining, operating and improving public works or capital improvements and acquiring necessary equipment and furnishings therefor and paying debt service on any obligations issued to finance such improvements with the avails to be expended and used by the City in accordance with an intergovernmental agreement between the District and the City.

29. **L06-479 - Lafayette City-Parish Council, City of Carencro Sales Tax District** - 1% sales tax, purchasing, constructing, acquiring, extending, maintaining, operating and improving public works or capital improvements and acquiring necessary equipment and furnishings therefor and paying debt service on any obligations issued to finance such improvements with the avails to be expended and used by the City in accordance with an intergovernmental agreement between the District and the City.
30. **L06-480 - Lafayette City-Parish Council, Town of Duson Sales Tax District** - 1% sales tax, purchasing, constructing, acquiring, extending, maintaining, operating and improving public works or capital improvements and acquiring necessary equipment and furnishings therefor and paying debt service on any obligations issued to finance such improvements with the avails to be expended and used by the Town in accordance with an intergovernmental agreement between the District and the Town.
31. **L06-481 - Lafayette City-Parish Council, City of Scott Sales Tax District** - 1% sales tax, purchasing, constructing, acquiring, extending, maintaining, operating and improving public works or capital improvements and acquiring necessary equipment and furnishings therefor and paying debt service on any obligations issued to finance such improvements with the avails to be expended and used by the City in accordance with an intergovernmental agreement between the District and the City.
32. **L06-414 - Fire Protection District No. 4, Lafourche Parish** - 8.45 mills tax, 10 years, 2007-2016, for the purpose of acquiring, constructing, improving, maintaining and/or operating fire protection facilities and equipment in the district including the purchase of fire trucks.
33. **L06-422 - South Lafourche Levee District** - 1% sales tax, constructing and maintaining necessary levees, levee drainage, flood protection and for all other purposes thereto, subject to funding into bonds for any of the capital purposes above.
34. **L06-466 - LaSalle Parish Police Jury** - 1% sales tax distributed as follows: 34% of the proceeds will be used for the purpose of constructing, improving, maintaining and resurfacing public roads and bridges in said parish, including incidental drainage, acquiring, operating and maintaining equipment for such purposes; 34% to the LaSalle Parish sheriff's office for general operations; 12% to the town of Jena for general operations; 7% to the Town of Olla for general operations; 5% to each of the towns of Urania and Tullos for general operations; and 3% to the LaSalle Economic Development District for general operations with the proceeds of the tax to be subject to funding into bonds for said capital purposes.
35. **L06-484 - Special Taxing District No. 5 (Gravity Drainage District No. 5), Livingston Parish** - ½% sales tax, 10 years from the date of first levy, acquire drainage works, equipment and facilities necessary to construct, maintain and operate outlets for waters of the District and prevent flooding, subject to funding into bonds to pay the capital costs of gravity drainage improvements.
36. **L06-442 - Afton Fire Protection District, Madison Parish** - \$125 service charge, 10 years, 2006-2015, for the purpose of paying the costs of fire protection services, including the cost of acquiring, operating and maintaining equipment and facilities necessary for such fire protection services.

37. **L06-473 - Madison Parish Police Jury - (1)** 7 mills tax, 10 years, 2007-2016, constructing, improving, equipping, operating, maintaining and supporting the Courthouse and jail; **(2)** 3 mills tax, 10 year, 2007-2016, acquiring, constructing, improving, maintaining and/or operating an enhanced 911 telephone system; **(3) Sales Tax District No. 1** - 2% sales tax, 10 years, 2007-2017, constructing, improving, maintaining and resurfacing public roads in the District, including providing incidental drainage, and acquiring, operating and maintaining equipment for said purposes, the proceeds of the tax to be subject to being funded into bonds for said capital purposes.
38. **L06-411 - Morehouse Parish Police Jury** - .50 mill tax, 10 years, 2007-2016, for the purpose of improving, operating, maintaining and equipping the Morehouse Parish extension office of the LSU Agricultural Center, including salary support and costs of programs administered by said office.
39. **L06-443 - Point Coupee Parish Police Jury** - 1/4% sales tax, 10 years beginning July 1, 2007, capital improvements, maintenance and operation of the Pointe Coupee Parish Health Services District Number One.
40. **L06-488 - Red River Parish Communications District** – authority to levy emergency telephone service charges not to exceed 5% of the tariff rate for local telephone service supplied within the District and 85 cents per month per wireless commercial mobile radio service connection which enables service users to access the 911 emergency telephone number, establishing, building, equipping, maintaining, operating and supporting the enhanced 911 emergency telephone system, subject to funding into bonds or other obligations permitted by law.
41. **L06-413 - Town of Mangham, Richland Parish** - 1% sales tax, 2007-2016, providing funds for any lawful corporate purpose of the Town.
42. **L06-426 - St. Bernard Parish Council - (1)** 1.24 mills tax, 10 years, 2007-2016, for constructing, maintaining, improving and operating public libraries; **(2)** 2.50 mills tax, 10 years, 2010-2019, for constructing, maintaining, improving and operating public libraries and for purchasing books and other library materials; **(3)** 2.19 mills tax, 10 years, 2007-2016, for acquiring or improving lands, buildings and equipment for recreation purposes, title to which shall be in the public, and maintaining and operating such recreation in said parish; **(4)** 0.63 mill tax, 10 years, 2007-2016, for constructing, maintaining, improving and operating public health units in said parish; **(5)** 0.95 mill tax, 10 years, 2007-2016, for providing funding for senior citizens programs, activities and services operated by said parish and/or the St. Bernard Parish Council on Aging; **(6) Garbage District No. 1** - 3.08 mills tax, 10 years, 2007- 2016, for providing and maintaining garbage collection and disposal services in said district; **(7) Road District No. 1** - 3.08 mills tax, 10 years, 2007-2016, for constructing, improving and maintaining public roads and highways in said district; **(8) Road Lighting District No. 1** -1.23 mills tax, 10 years, 2007-2016, for providing and maintaining electric lights on the streets, roads, highways, alleys and public places in said district; **(9) Fire Protection District No. 1** - 2.77 mills tax, 10 years, 2007-2016, for maintaining and operating said district’s fire protection facilities and paying the cost of obtaining water for fire protection purposes, including charges for fire hydrant rentals and services; **(10) Fire Protection District No. 1** - 4.66 mills tax, 10 years, 2009-2018, for acquiring, constructing, maintaining, improving and operating fire protection facilities and purchasing fire trucks and other fire fighting equipment; **(11) Fire Protection District No. 2** - 8.35 mills tax, 10 years, 2009-2018, for acquiring, constructing,

maintaining, improving and operating fire protection facilities and purchasing fire trucks and other fire fighting equipment in the District.

43. **L06-465 - St. Helena Parish Police Jury** - 1% sales tax for funding waste collections and disposal, including, but not limited to, providing, maintaining, operating, constructing, acquiring and/or improving solid waste collection and disposal facilities, equipment and/or waste services in the Parish, subject to funding into bonds for said capital purposes.
44. **L06-399 - St. Martin Parish Water and Sewer Commission No. 1** - 8.00 mills tax, 10 years, 2007-2016, for the purpose of acquiring, constructing, improving, maintaining and operating sewers and sewerage disposal works, including the payment of principal and interest on any debt obligations previously issued by Sewerage District No. 1 of the Parish of St. Martin or hereafter issued by the Commission to construct, acquire, and improve sewers and sewerage disposal works.
45. **L06-470 - City of Houma, Terrebonne Parish** - (1) 5.08 mills tax, 10 years, 2009-2018, acquiring, constructing, improving, maintaining and operating fire protection facilities including the purchase of fire trucks and equipment; (2) 5.08 mills tax, 10 years, 2009-2018, for the purpose of providing additional revenues for police protection.
46. **L06-471 - Terrebonne Parish Council** - (1) 11.21 mills tax, 10 years, 2008-2017, for the purpose of providing and maintaining solid and liquid waste collection and disposal facilities and services and purchasing the necessary sites and equipment; (2) 7.31 mills tax, 10 years, 2008-2017, for the purpose of operating, maintaining and constructing drainage works; (3) 5.33 mills tax, 10 years, 2008-2017, for the purpose of operating, maintaining and constructing schools for the mentally retarded and to administer to the health and educational requirements of trainable and below trainable individuals.
47. **L06-472 - Terrebonne Parish Council - (1) Road Lighting District No. 2** - 3.99 mills tax, 10 years, 2008-2017, for providing and maintaining electric lights on streets, roads, highways, alleys and public places; **(2) Road Lighting District No. 4** - 4.75 mills tax, 10 years, 2008-2017, for providing and maintaining electric lights on streets, roads, highways, alleys and public places; **(3) Road District No. 6** - .82 mills tax, 10 years, 2009-2018, for acquiring, building, improving or maintaining public roads or highways.
48. **L06-475 - Hospital Service District No. 3, Vermilion Parish** - 7.00 mills tax, 10 years, 2007-2016, (heretofore levied for purpose of paying debt service on outstanding General Obligation Refunding Bonds, Series 1997, of the District) for improving and maintaining the buildings and capital facilities of the district and acquiring furnishings and equipment.
49. **L06-415 - Washington Parish Fire Protection District No. 1** - **(1)** not exceeding \$735,000 General Obligation Bonds, not exceeding 8%, not exceeding 15 years, acquiring, constructing and improving buildings, machinery and equipment, including both real and personal property, to be used in giving fire protection to the property in said district; **(2)** 8.46 mills, 10 years, 2007-2016, for acquiring, constructing, improving, maintaining and/or operating fire protection facilities and equipment, including the cost of obtaining water for fire protection purposes; **(3)** 5 mills tax, 10 years, 2007-2016, for acquiring, constructing, improving, maintaining and/or operating fire protection facilities and equipment, including the cost of obtaining water for fire protection purposes.

50. **L06-416 - West Carroll Parish School Board, West Carroll Parish School District** - 6.08 mills tax, 5 years, 2007-2011, for giving additional support to the public schools in the district.
51. **L06-459 - West Carroll Parish Law Enforcement District** - 10.87 mills tax, 10 years, 2007-2016, for the purpose of providing financing to the office of the Sheriff of West Carroll Parish, including but not limited to, constructing, acquiring, improving, operating and maintaining law enforcement facilities, vehicles and equipment and paying salaries and benefits of deputies.
52. **L06-482 - West Feliciana Parish Police Jury, Sales Tax District No. 1** - ½% sales tax, for a period of 6 years, commencing October 1, 2007, acquiring, constructing, improving, maintaining, supporting and/or operating recreational parks, facilities, equipment, programs and services, and at the discretion of the governing authority of the District, up to 25% of the annual proceeds may be used for maintaining and supporting social services and programs, subject to funding into bonds or other indebtedness pay the cost of capital improvements for such purposes.
53. **L06-474 - Winn Parish School Board** - 7.57 mills tax, 10 years, 2007-2016, for the purpose of providing and giving additional aid and support to the public schools of the Parish.

54. **L06-436 - City of Donaldsonville, Ascension Parish** - Not exceeding \$250,000 Revenue Anticipation Note, not exceeding 6%, maturing not later than March 1, 2007, paying current expenses.
55. **L06-444 - City of Donaldsonville, Ascension Parish** - Not exceeding \$1,800,000 Certificates of Indebtedness, not exceeding 7.5%, not exceeding 10 years, (i) refunding a lease-purchases equipment lease, and Certificates on Indebtedness, Series 2002, (ii) constructing and maintaining public roads, highways and bridges, (iii) acquiring a waterworks system and (iv) purchasing a fire truck.
56. **L06-445 - City of DeRidder, Beauregard and Vernon Parishes** - Not exceeding \$245,000 Certificates of Indebtedness, not exceeding 3.95%, to mature on August 2, 2011, acquiring and equipping a fire truck.
57. **L06-446 - East Baton Rouge Parish Law Enforcement District** - not exceeding \$6,000,000 Revenue Anticipation Note, not exceeding 5%, maturing no later than March 1, 2007, paying current expenses.
58. **L06-407 - City of Ville Platte, Evangeline Parish** - Not exceeding \$250,000 Certificates of Indebtedness, not exceeding 8%, not exceeding 10 years, purchasing a firefighting vehicle.
59. **L06-299A - City of Carencro, Lafayette Parish** - To amend the amount of the loan approved by the SBC at the meeting on July 20, 2006 from not exceeding \$2,550,000 Certificates of Indebtedness to not exceeding \$3,000,000 Certificates of Indebtedness, not exceeding 6%, not exceeding 20 years, constructing and acquiring improvements to the Issuer's utilities system.

60. **L06-388A - Livingston Parish Council** - To amend the amount and rate of interest of the loan approved by the SBC at the meeting on August 17, 2006, from not exceeding \$200,000 Certificates of Indebtedness, not exceeding 6% to not exceeding \$490,000 Certificates of Indebtedness, not exceeding 8%, not exceeding 10 years, constructing and acquiring improvements, extensions and replacements to the waterworks system located in the Bruce's Harbor area. The bids came in higher than the approved amount.
61. **L06-395 - Rapides Parish School Board** - Not exceeding \$1,700,000 Certificates of Indebtedness, not exceeding 6%, not exceeding 10 years, purchasing school buses and maintenance vehicles.
62. **L06-400 - Town of Woodworth, Rapides Parish** - Not exceeding \$420,000 Excess Revenue Note, not exceeding 4.75%, not exceeding 10 years, purchasing the Bayou Latanier Water System.
63. **L06-417 - Red River Parish Police Jury** - Not exceeding \$50,000 Certificates of Indebtedness, not exceeding 4.5%, not exceeding 7 years, paying a portion of the costs of purchasing a road grader.
64. **L06-398 - Town of Washington, St. Landry Parish** - Not exceeding \$100,000 Certificates of Indebtedness, not exceeding 6%, not exceeding 5 years, acquiring machinery, equipment and materials for the waterworks system, including the acquisition of auxiliary generators.

- B. L06-448 - City of Donaldsonville, Ascension Parish** - Not exceeding \$1,300,000 Bond Anticipation Notes, not exceeding 6%, maturing no later than 1 year, to provide interim financing.



69. **L06-449 - Orange Grove Community Development District, Ascension Parish** - Not exceeding \$8,570,000 Special Assessment Bonds, not exceeding 8%, not exceeding 15 years, finance, fund, plan, establish, acquire, construct or reconstruct, enlarge, extend, equip, operate and maintain systems, facilities and basic infrastructure for the following: (i) surface water management and control systems, (ii) water distribution and transmission and wastewater collection and transmission facilities, (iii) roadwork, (iv) related incidental costs (including assessment prepayments on transferred property), (v) financing up to twenty-four months of capitalized interest on the bonds, (vi) funding a reserve for the Bonds, if required.
