3. **L07-497 - Assumption Parish School Board, School District Number One** - 6.97 mills tax, 10 years, 2009-2018, giving additional support to public elementary and secondary schools in the Parish.
4. **L07-544 - North Bienville Parish Fire Protection District** - 5.71 mill tax, 10 years, 2009-2018, acquiring land and purchasing or constructing of buildings, facilities, fire trucks or other vehicles and fire fighting equipment of any kind whatsoever and for the maintenance and operation thereof.
5. **L07-559 - Bossier Parish, East-Central Bossier Parish Fire District No. 1** - 19 mills tax, 10 years, 2009-2018 for purchasing, constructing, maintaining and operating the District's fire protection facilities and equipment and pay the cost of obtaining water for fire protection purposes.
